

## **Terms and Conditions of use for the website and the online directory, INSEAD Connect (alumni.insead.edu)**

By logging into the site, the user agrees to and adheres to these terms and conditions in order to maintain access to the Alumni Online application and its third-party services. This site is published by INSEAD. The Site is provided to you subject to the its terms and conditions (as displayed on the site and as varied from time to time), which apply to all content available through the INSEAD Alumni online directory or under the host name "alumni.insead.edu" or any domain name alias to the same content. Please read them carefully. By accessing and using our Site, you agree to these terms, as set out below and as varied for operational reasons by INSEAD, from time to time. Your compliance with the terms and conditions of the site is required in order for you to be authorised to view its contents and use the Site either as a visitor or as an Alumnus/a having membership access.

### **1. Rules for online conduct**

You agree to use the Site in accordance with all applicable laws and giving all consents necessary for the operation of the Privacy Policy. The Site should be used by you solely as an end user for your own personal needs only. It is strictly prohibited to use the Site, and in particular the online directory, for any commercial or professional purpose, including, without limitation, fundraising/soliciting for other nonprofit organizations, sending unsolicited chain emails (SPAM), sharing and/or selling mailinglists generated from the directory. ### **3. Use of site content**

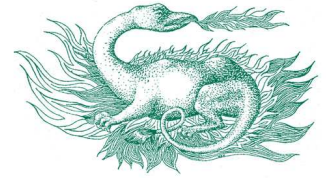

### **4. Access**

INSEAD is authorized to give access to the site, its data and content, to their employees, agents and subcontractors for all purposes permitted by the statutes of either of them.

### **5. Grant of rights to use data and agreement to abide by other legal obligations:**

Alumni users of this site hereby consent to their personal data, whether collected as a result of their access to this site or otherwise supplied by them to INSEAD, being furnished to



National Associations which are part of the IAA, in electronic or hard copy form, for the fulfilment of the purposes of the IAA whether or not that National Association is in the European Union or in a state recognized by the European Union as having equivalent data protection laws. All users of this site, whether alumni or people authorised by INSEAD, the IAA or a National Association agree that, with respect to all data on it and any other data obtained by them about alumni from INSEAD of the IAA derived from this site, they will abide by (a) the "Protocole d'Accord" signed 5 September 2003 governing the relationships between INSEAD and the IAA with regard to such data; (b) all applicable data protection laws in the European Union, including Directives 94/56EC and 02/58EC as if those laws governed the relationship between them, INSEAD, the IAA and any relevant National Association which is a member of the IAA, with respect to data. ## **6. Membership**

You shall ensure that no other person has access to the restricted areas of the Site. In the event that you have knowledge of a person who is not entitled to have the necessary codes accessing the restricted areas of the Site, you shall immediately bring this fact to the attention of INSEAD and confirm the information by e-mail and/or registered letter.

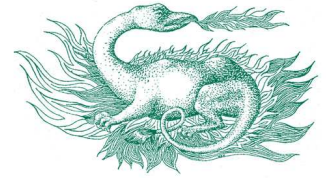
## **8. Evidence**

This is an e-mail forwarding feature allowing Alumni to redirect e-mails sent to their "Lifetime" e-mail address to their own specific address. There is no obligation on INSEAD to maintain the "Lifetime" email feature for any given period of time or at any specific time. Alumni are responsible of the usage of this feature, which is made available only for private, non-business and non-commercial correspondence with other Alumni, with INSEAD or its representations and divisions in France and in the World.

## **10. Monitoring**



INSEAD reserves the right to monitor your use of the site to improve the quality as well as to avoid misuse, including breach of the terms and conditions relating to access to and use of the site.

## **11. User Postings**

You acknowledge, agree and guarantee that all postings comply with all applicable laws. You equally agree that neither INSEAD and nor its representations and divisions are responsible for any content posted. 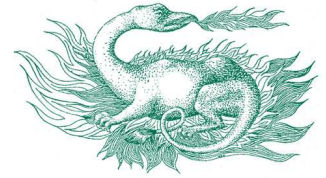
Prohibited conduct:
